Required Documentation

- If changes were made to the Foster Care Plan, please upload the updated plan
- All Documentation can be scanned and uploaded
- *No special characters in the file name*
- Please indicate if no response from private/home schools
- Grant cannot be approved until documentation is received

Title I Application - Targeting Step 4

- Targeting Step 4
 - Set Asides
 - Private School Share will be taken off the top of the district allocation
 - Homeless, Neglected and Delinquent

Title I Application - Targeting Step 4

Set Asides - Continued

- 1% Parent Involvement
 - If allocation is \$500,000 or more
 - 90/10 School/District Split
 - Will still be required to match the budget page
- School Improvement Set Asides are no longer utilized
- Required Professional Development Set Aside is no longer utilized
- School Improvement Tab is being removed
