WDE602/652 FTE Changes for 2019-20

To increase accuracy of FTE calculation, WDE will be eliminating the subtraction of *Holiday Hours* from *Annual Hours*. Districts will begin reporting *Assignment Hours* and *Assignment Days* instead of *Hours* and *Contract Days* worked for both classified (hourly) and non-salary scheduled contract assignments.

The FTE calculation changes for 2019-20 are:

- 1) to no longer require reporting of *Holiday Hours* as a separate field:
- 2) for classified (hourly) assignments, change reporting of assignments to add reporting of *Assignment Days* and *Assignment Hours*; and
- 3) for non-salary schedule contract assignments, add *Assignment Hours* along with *Assignment Days*, in conjunction with eliminating the reporting of *Time* for these assignments.

The final two changes listed above allow consideration of hours worked per day for a more accurate FTE calculation.

WDE602/652 data element changes for 2019-20

Summary of changes:

- For scheduled contract positions (employees on salary schedule), no change needed.
- The removal of reporting *Holiday Hours* reported separately for classified (hourly) employees. Add *Assignment Days* and change *Annual Hours* to *Assignment Hours*.
- For non-salary schedule contract employees, change from *Time* to *Assignment Hours* and *Contract Days* renamed *ContractOrAssignment Days*.
